Frequently Asked Questions

Who are the students who are served by Take Stock in Children?

- Our population is comprised of middle and high school students who attend Palm Beach County schools.
- They must income-qualify and meet at-risk guidelines.
- They are chosen by interview committees that represent the local community.
- They are required to have a 2.5 GPA or higher; remain drug-free and crime-free.
- They sign a contract that requires both student and family members to make a long-term commitment.
- Each student is matched with both a mentor and a college readiness coach to begin their journey. Students must meet weekly with their mentor during the school year and must meet monthly with their college readiness coach in order to successfully comply with program requirements.
- A probation process is in place to monitor each student's academic standing, behavior, and mentor meetings.

What do I need to know about the Florida Prepaid Scholarship?

- This is a 2-year Florida Prepaid college tuition scholarship.
- This scholarship can be used at any of Florida's 11 State Universities and 28 Florida colleges (formerly known as community colleges). The scholarship pays at the State college tuition rate.
- Students can also pursue a 2-year vocational/technical degree offered at any of the state colleges, i.e., fire academy, police academy, diesel mechanic certification programs.
- Through a \$1 for \$1 match with Florida Prepaid College Foundation, college scholarship plans are purchased prior to students entering the program.
- The scholarship does not cover additional college expenses, such as fees, books, transportation, and housing.
- The scholarship does not guarantee admission to any college or university. Students must complete the traditional application process.

What is the job of a College Readiness Coach?

- To facilitate college readiness activities that ensure academic success.
- To work closely with both mentors and school personnel to provide each student with tools for future success.

- To monitor student progress and provide interventions as needed.
- To maintain accurate, up-to-date files on each student they serve.
- To assist in both planning and attending Take Stock in Children activities and events.

What other funding sources exist for Take Stock in Children students?

- The Free Application for Federal Student Aid, or FAFSA, gives students access to the largest source of financial aid available to both university and college students. Grants such as Federal Pell Grants, Federal Supplemental Educational Opportunity Grants, and Teacher Education Assistance for College & Higher Education Grants are examples of grants available. Student eligibility for most federal student aid depends on a variety of factors, including Expected Family Contribution (EFC), the year in college, student enrollment status, and the cost of attendance at the college student will be attending. *FYI: Take Stock in Children staff provide a yearly workshop for seniors in order to facilitate this process.*
- A Florida Bright Futures Scholarship for qualifying seniors also provides funding opportunities for eligible students. The minimum GPA to qualify is a 3.0 plus 75 community service hours.
- The Community Foundation of Palm Beach County offers over 100 scholarship opportunities for Palm Beach County students.
- To maintain any scholarship, a student must remain in good academic standing throughout their university/college program of study.

What is the role of the College Retention Coach?

- Take Stock in Children recognizes a gap between our high school graduation rate and college completion rate. Our goal is to close that gap by providing our college students with the support of a College Retention Coach.
- To monitor the progress of Take Stock in Children high school graduates once they enter the postsecondary setting.
- To develop collaborative relationships with universities/colleges where Take Stock in Children graduates attend.
- To provide interventions for Take Stock in Children university/college students who are in need, as warranted.
- To coordinate with the Take Stock in Children State Office Alumni Department.
